This mortgage lies shall cont. "e it force and exist as security for any and all other advances which may hereafter be nade by the Mortgage to the Mortgage, and sould continue in force and exist as security for any debt now owing, or hereafter to become owing, by the Mortgages as the Mortgages.

The Mortgagors hereby (jointly and severally if more than one) covenant and agree with the Mortgagee as follows:

That the Mortgagors have a valid, unincumbered (life in fee straple to said premises, and will warrant and forever defend the same against the lawful claims and demands of all person whomsoever.

That it a Mortgagors will during the continuance of this martgage, permit no waste or strip of the mortgaged premises and will keep the buildings and appurtenances on said property in good state of repair.

That the Mortgagors will pay said promissor, note according to its terms. Should the Mortgagors fail to pay any installment of principal or interest provided for it said note, or any sum due under this mortgage, or breach of any covenant or agreement, crein contained, then the entire debt secured by this mortgage shall, at the election of the Mortgage, become immediately due and payable. Should the Mortgagors fail to pay any sum which they are required to pay, the Mortgagee may, without waiver of any semedy hereunder for such thecach, make full or partial payment thereof, and the amount so paid with interest thereon at 10°, per annum shall become immediately payable to the Mortgagee and shall be secured by this mortgage. Any payments made by the Mortgagors upon the indebtedness secured by this mortgage may be applied as the Mortgagoe may elect either upon the amount which may be due upon said promissor; note or upon any amount which may be due under the provisions of this mortgage.

That the Martgagors will keep all buildings thereon continuously insured against loss or damage by fire and such other hazards as the Martgagors may appelly to the extent of the amount due hoteunder, in some responsible insurance company or companies satisfactory to the Mortgagor and for the protection of the latter, and that the Mortgagors will cause all insurance policies to be suitably endorsed and delivered to the Mortgagee, together with receipts showing payment of all prendums due therefor, and that the Mortgagors will keep no insurance on said building other than as stated herein. That it shall be optional with the Mortgagor to name the company or companies and the agents thereof by which the insurance shall be written, and to refuse acceptance of tay policy offered, and to surrender and cause to be cancelled any policy which may be received or accepted and to place the insurance or cause the policies to be written, all at the cyst, charge and expense of the Mortgagors; but in no event shall the Mortgagore be held responsible for failure of have any insurance written or for any loss or damage growing out of a defect in any folicy, or growing out of the failure of any insurance campany to pay for any loss or damage insured against. That the Mortgagors and their assigns and the Mortgagore.

That the Mortgagors will pay all taxes, assessments, and other governmental levies, now or hereafter assessed against the mortgaged premises, or imposed upon this mortgage or the note secured hereby, as soon as the same become due and payable, and shall immediately pay and discharge any lien having precedence over this mortgage. And to assure prompt payment the Mortgagors agree to pay to the Mortgagee monthly budget payments estimated by the Mortgagee to equal one-twelfth of the annual insurance premiums, taxes, assessments, and other governmental levies, which are or may become due upon the mortgaged premises, or upon this mortgage or the note secured hereby, the amount of such payments to be adjusted from time to time as conditions may require. The budget payments so accumulated may be applied by the Mortgagee to the payment of such taxes, assessments, or levies, in the amounts shown by the official statements thereof, and to the payment of insurance premiums in the amount actually paid or incurred therefor. And such budget payments are hereby pledged to the Mortgagee as collatoral security for full performance of this mortgage and the note secured hereby and the Mortgagee may, at any time, without notice, apply said budget paymen's upon any sums delinquent upon said note or under the terms of this mortgage.

In any action brought to foreclose this mortgage or to protect the ilen hereof, the Mortgagee shall be entitled to recover from the Mortgagors a reasonable attorney fee to be allowed by the court, and the reasonable cost of searching the records and obtaining abstracts of title or title reports for use in said action, and said tums shall be secured by this mortgage. In such foreclosure action a deficiency judgment may be entered in favor of the Mort tagee, and a receiver may be appointed at the Mortgagee's request to collect the rents, issues and profits from the mortgaged premises.

And it is further covenanted and agreed that the owner and holder of this mortgage and of the premissory note secured hereby shall have the right, without notice, to grant to any person liable for said mortgage indebtedness, any extension of time for payment of all or any part thereof, without in any way affecting the personal liability of any party obligated to pay such indebtedness.

Wherever the terms "mortgagors" occur herein it shall mean "mortgagor" when only one person executed this document, and the liability hereunder shall be joint and several.
