## EASEMENT

KNOW ALL MEN BY THESE PRESENTS, that Melvin Evans and Charlotte Evans, husband and wife, Edward C. Hewitson and Mary Jane Hewitson, husband and wife, and George Bunt and Betty Jean Bunt, husband and wife, hereinafter called Grantors, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration to them paid by Northwest Natural Gas Company, an Oregon corporation, hereinafter called Grantee, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell and convey unto the said Grantee, its successors and assigns, the right of way and easement to lay, maintain, operate, change the size of, repair, replace and remove a gas pipeline or pipelines and appurtenances in, along, upon and across a portion of a tract of land known as Government Lot 9, Section 16, T. 2 N., R. 7 E., W.M., Skamania County, Washington, said easement being more particularly described as being twenty (20) feet in width, lying ten (10) feet on either side of and parallel with the following described centerline:

It is expressly understood that said gas pipeline(s) shall be laid two feet, more or less, below the surface of the ground, in a good and workmanlike manner, and the surface of the ground restored as nearly as practicable to the same condition it was in prior to the laying of said pipeline(s); that no building or other structure will be constructed upon said easement; and that no operations will be carried on upon said premises which will jeopardize the safe operation of said pipeline(s).
