ORDER APPROVING FINAL

DeWitt Jones, his attorney, and the Court having examined the records and files herein, and having heard and considered the evidence produced and the remarks of counsel, and being fully advised, makes the following findings:

I.

That Myrtle Voorhees Hessel, died intestate at Spokane, Spokane County, Washington, on the 18th day of August, 1960, being at the time of her death a resident of Spokane County, Washington.

II.

That your petitioner, Carl Arbour, was appointed Administrator of the above entitled estate on the 30th day of September, 1960, and as such has duly qualified.

III.



That Shirley Knight was appointed guardian ad litem for Jesse D. Voorhees and Susan R. Voorhees, the minor heirs of the above entitled estate, and that her report as such guardian ad litem is on file herein.

XV.

That this estate is now in a condition for final settlement and the assets remaining in said estate being in the total sum of Thirteen Thousand Four Hundred Nine and 71/100 Dollars (\$13,409.71) ought be distributed share and share alike to the four surviving children of Myrtle Voorhees Hessel, deceased, each to receive an equal share in the assets of Three Thousand Three Hundred Fifty Two and 43/100 Dollars (\$3,352.43) each, said property to be distributed as follows in accordance with an agreement among the heirs:

NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the Final Report as rendered by this Administrator be, and the same hereby is approved and confirmed; that all the assets

remaining in said estate, being in the total sum of Thirteen Thousand Four Hundred Nine and 71/100 Dollars (\$13,409.71) be, and the same hereby are distributed share and share alike to the four surviving children of Myrtle Voorhees Hessel, deceased, each to receive an equal share in the assets of Three Thousand Three Hundred Fifty Two and 43/100 Dollars (\$3,352.43) each, said property to be distributed in accordance with an agreement among the heirs, as follows, to-wit:

JAN VOORHEES - Distributive share to be lots in Skamania County as inventoried herein for the agreed price of----- \$ 550.00

JESSE D. VOORHEES - Distributive share to be cash in the sum of----- 3,352.43

SUSAN R. VOORHEES - Distributive share to be cash in the sum of----- 3,352.43
----- \$13,409.71

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the distributive share of Susan R. Voorhees, a minor, be deposited with the County Clerk until the further order of this court;

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that a reasonable attorneys fee in this matter be, and the same hereby is fixed in the sum of Five Hundred Fifty Dollars (\$550.00);

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that this Administrator be, and he hereby is discharged from his trust as

such Administrator and his bondsmen are hereby relieved from all liability thereunder.
