Begining at the iron pin marking the center of section 34, Township 2, N., R.
Range 6, W.M. 1/4 thence north 00° 26' west along the west line of the S. 1/4 of
the NW 1/4 of the said section 34 a distance of 590 feet; thence north 89° 34'
east 30 feet to the easterly right of my line of the county road known
and designated as Goodard Creek Road (County Rd. No. 1014), said point being
the initial point of the tract hereby described; thence north 89° 34' east
220 feet; thence north 00° 26' west 220 feet; thence south 89° 34' west 180 feet,
& more or less, to the easterly right of my line of said Goodard Creek Road;
thence southerly following said right of way to the initial point.
