## PARTIAL RELEASE OF REAL ESTATE MORTGAGE

of the Biddle access road EXCEPT the East 330 feet of the Northeast Quarter  
of the Southwest Quarter of Section 9, Township 1 North, Range 5 East of  
W.M.

The South one-half of the Southwest Quarter of Section 9, Township 1 North,  
Range 5 East of W.M. EXCEPT a tract described as follows:

Starting at a point 330 feet North of the Southwest corner of Section 9;  
thence East 792 feet; thence North 981.2 feet; thence West to the West  
line of Section 9; thence South to point of beginning.
