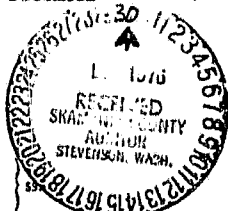
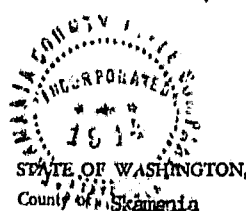
to secure payment of the sum of SEVEN THOUSAND FIVE HUNDRED and 00/100

Beginning at a point on the westerly line of Russell Street in the Town of Stevenson
which is north 34 degree 30' west 31.2 feet from the northeast corner of Lot 1, Block
Eight of the Town of Stevenson according to the official plat thereof on file and of
record in the office of the Auditor of Skamania County, Washington; thence south 34 degree
30' east a distance of 33 feet; thence south 55 degree 30' west 4 1/2 feet to the
southeasterly corner of the brick and tile building known as "Skamania County Abstract
& Title Company Building"; thence on the same course along the southerly wall of said
building a distance of 25 feet to the angle corner of the brick annex of said building;
thence north 34 degree 30' west along the westerly wall of the brick annex a distance
of 3.5 feet; thence south 55 degree 30' west a distance of 77.0 feet; thence north 34
degree 30' west 29.5 feet; thence north 55 degree 30' east a distance of 106.5 feet to

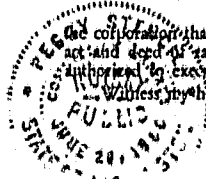
