ORDER APPROVING FINAL REPORT AND DECREEING DISTRIBUTION

HENRY KAPP, Deceased.

This matter coming on regularly for hearing on the final report and petition for distribution herein; the executrix appearing personally and with her attorney. Ned Hall; the Court having heard the evidence and being fully advised finds:

ī.

That due and proper notice of this hearing has been given in the manner and form required by law.

That Henry Kapp died testate January 9, 1963 in Skamania County, Washington, being at the time of his death a resident of White Salmon, Klickitat County, Washington, and leaving an estate subject to administration in said counties, which was the community property of himself and Erma M. Kapp, his surviving wife.

III.

That decedent's Will was duly and regularly admitted to probate, and Erma M. Kapp qualified as executrix and is now the duly appointed, qualified and acting executrix herein.

IV.

That she gave notice of her appointment and to creditors in the manner and form required by law, the first publication being more than six months prior to the filing of the final report herein, and that three claims were FILED

and that said claims have been paid and payment is approved.

V.

That the estate was appraised at \$123,027.06; that inheritance tax due the State of Washington in the sum of \$884.31 has been paid; that federal estate tax in the sum of \$416.00 has been paid and receipts therefor are filed herein.

VI.

That the accounting of the executrix correctly sets forth receipts and disbursements made by her to date; that subsequent to the filing of the report notice of hearing was published at a cost of \$ 900; that the accounting shows the executrix has cash on hand in the sum of \$5901.82, less the aforesaid publication cost.

VII.

That decedent left surviving him his wife, Frma M. Kapp, White Salmon, Washington; a daughter, Shirley Ann Kapp Azure, White Salmon, Washington; and two sons, David Henry Kapp of Enumelaw, Washington, and Jack Duane Kapp of Cheney, Washington; that all said persons are over the age of twenty-one years; that there are no deceased children.

VIII.

That in his Last Will he bequeathed to his wife the home, household furniture and furnishings, family automobile and his personal effects and the remainder of his community estate he left to his wife in trust, with the right under the Will and State statute to hold, manage, sell, invest and reinvest in her discretion, and with the right to use the net income from the trust as she

may desire, and on her death all of the property then remaining in the trust estate to go to the three said children share and share alike, and if any child predeceases the wife, then such child's share to go to his descendants per stirpes.

IX.

That the estate is now ready to be distributed; that \$3550.00 is a reasonable attorney's fee; that payment of other expenses of probate have been made, now, therefore,

IT IS ORDERED, ADJUDGED AND DECREED as follows:

- 1. That the executrix has performed every act required of her, and her accounting is hereby approved in all respects and allowed.
- 2. That all creditor's claims and taxes due the United States and the State of Washington have been paid, and such payment is hereby approved.
- 3. That the payment of attorney's fees and costs of probate as herein set forth out of funds on hand in the estate is hereby approved and confirmed.
- 4. That the following property is hereby distributed to the surviving spouse as her sole and separate property, to-wit:
