- 3. That the Inheritance Tax of the state of Washington has been finally determined and fixed in the amount of \$123,559.78 and has been paid in full.
- 4. That all debts of the estate, including all the funeral expenses, have been paid in full.
- 5, That a fee in the amount of \$38,000.00 be and it is hereby approved and allowed for the attorney for the executrix for his services in connection with the administration of this estate; and a fee in the amount of \$50.00 be and it is hereby approved and allowed for the guardian ad litem.
 - 6. That the executrix be and she is hereby given credit for all
