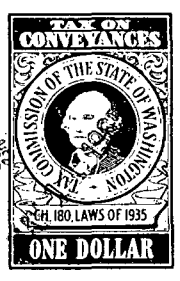
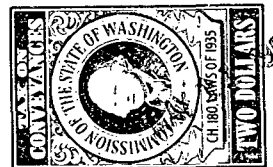
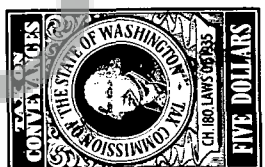
THE GRANTOR TARI SKAALHEIM, who acquired title as Dolores R. Salvesen, dealing with her separate property,

the following described real estate, situated in the County of Skamania, State of Washington:

Beginning at an iron pipe on the northerly line of the road which prior to March 16, 1937, was known as State Highway No. 8, which said iron pipe is on the east line of that tract of land heretofore conveyed to Charles Kane et ux. by Edward W. Fields by deed dated June 6, 1941, and recorded at page 350 of Book 28 of Deeds, Records of Skamania County, Washington, and which said iron pipe is located in Section 1, Township 2 North, Range 7 E. 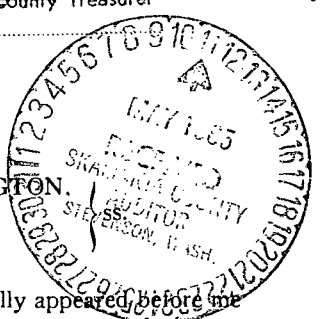

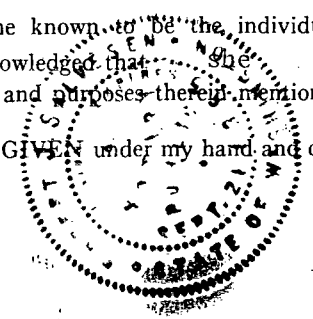
