BOUNDARY LINE AGREEMENT

This agreement is made and entered into by and between:

John H. Smith, III and Nancy S. Smith, husband and wife, first parties; and

Donald M. Goode and Jennie K. Goode, husband and wife, second parties; and

Herbert Kiors and Vera E. Kiors, husband and wife, third parties.

First parties are the owners of a tract of land situated in the Northwest Quarter of Section 34, Township 2 North, Range 5 East, W.M., in Skamania County, Washington. Second parties are the owners of a tract of land situated in the same Quarter of Section 34, abutting on the South line of the tract owned by the first parties. Third parties have entered into a contract to purchase the tract owned by the second parties. The parties hereto have established a common boundary between their respective tracts of land and have marked the same with iron pipes. The purpose of this agreement is to fix and establish such line as marked as a common boundary line between the respective tracts of the parties.

In furtherance of such agreement the first parties convey and quitclaim to the second parties all interest in the land lying south of and adjacent to such line, and the second parties and the third parties convey and quitclaim to the first parties all interest in the land lying north of and adjacent to such line.
