

PARTIAL RELEASE OF SECURITY

KNOW ALL MEN BY THESE PRESENTS: That Max Cleland, as Administrator of Veterans Affairs, an Officer of the United States of America, does hereby remise, release and discharge any interests in and to the following described real property situate in the County of Skamania, State of Washington, to wit:

## LOT 1:

Beginning at the Southwest corner of the Southeast 1/4 of the Southeast 1/4 of said Section 15; thence North 00° 24' East 880 feet along the West line of said subdivision; thence South 00° 24' West along said West line, 93.5 feet to the True Point of Beginning of said Lot 1; thence North 89° 43' East 233 feet; thence South 00° 24' West 187 feet; thence South 89° 43' West 233 feet to said West line of said Southeast 1/4 of the Southeast 1/4 of said Section 15; thence North along said West line to the True Point of Beginning.

## LOT 2

Beginning at the Southwest corner of the Southeast 1/4 of the Southeast 1/4 of said Section 15; thence North 00° 24' East 880 feet along the West line of said subdivision; thence South 00° 24' West 280.5 feet to the True Point of Beginning; thence North 89° 43' East 233 feet; thence South 00° 24' West 187 feet; thence South 89° 43' West 233 feet to said West line of said Southeast 1/4 of the Southeast 1/4 of said Section 15; thence North along said West line to the True Point of Beginning. TOGETHER with an easement for ingress, egress and utilities over, under and across the South 10 feet of the West 233 feet of the North 477.5 feet of the above described entire contiguous ownership, and subject to an easement for ingress, egress and utilities over, under and across the South 10 feet of said Lot 2.

## LOT 3

Beginning at the Southwest corner of the Southeast 1/4 of the Southeast 1/4 of said Section 15; thence North 00° 24' East 880 feet along the West line of said subdivision; thence South 00° 24' West along said West line 280.5 feet; thence North 89° 43' East 233 feet to the True Point of Beginning; thence continue North 89° 43' East 233 feet; thence South 00° 24' West 187 feet; thence South 89° 43' West 233 feet; thence North 00° 24' East 187 feet to the True Point of Beginning.

TOGETHER with an easement for ingress, egress and utilities over, under and across the South 20 feet of the West 233 feet of the North 477.5 feet of the above described entire contiguous ownership.
