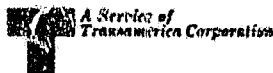

KNOW ALL MEN BY THESE PRESENTS That COLUMBIA GORGE BANK, a corporation the owner and holder of that certain mortgage bearing date the 3rd day of March, 1972, executed by JOHN E. HALVER and JANE L. HALVER, husband and wife to secure payment of the sum of Twenty Thousand and 00/100----- Dollars and interest, and recorded in the office of the County Auditor of Skamania County, State of Washington, on the 7th day of March, 1972, in Volume 49 of Mortgages, at page 611, being Auditor's File No. 74499, do hereby release and discharge from the lien of said mortgage the following described lands situate in the County of Skamania, State of Washington, to-wit:

Beginning at a point 380 feet East of the Southwest corner of E 1/2, NE 1/4 SW 1/4 of Section 21, Township 3 North, Range 10 East, W.M.; thence North 839 feet, more or less, to a stone monument lying on the southerly margin of county road known and designated as the Underwood-Willard Highway, said point being 179.7 feet east and 1801.1 feet south of the southwest corner of the E 1/2 NE 1/4 NW 1/4 of said Section 21; thence south 30° east 945 feet, more or less, to the south line of the NE 1/4 SW 1/4 of said section 21; thence westerly along said south line of NE 1/4 of SW 1/4 of said section 21 to point of beginning; together with an including an easement for road use and access to said lot 1 beginning at said stone monument; thence easterly along the southern boundary of said Underwood-Willard Highway for a distance of 30 feet; thence south 30° west 50 feet, more or less, to the junction of the east line of the above described parcel, thence North 30° west along said east line of said described parcel to point of beginning.
