## COMMUNITY PROPERTY AGREEMENT

This COMMUNITY PROPERTY AGREEMENT entered into this date between EMORY F. STEVENSON and IDA M. STEVENSON, husband and wife, both of Skamania County, State of Washington,

## WITNESSETH:

We do further mutually agree that any and all property of every kind and nature that may be hereafter acquired by us, or by either of us, is and shall be and become the community property of the both of us, and

IT IS FURTHER AGREED that the whole of the said community property now owned by us or hereafter acquired by us, including all such property the status of which is changed or created by this agreement, shall at once, in the event of the death of EMORY F. STEVENSON while the said IDA M. STEVENSON survives, be vested in the said IDA M. STEVENSON absolutely and in fee simple as her sole and separate property; and in the event of the death of the said IDA M. STEVENSON while the said EMORY F. STEVENSON survives, then the whole of the said community property now owned by us or hereafter acquired by us, including all property the status of which is changed or created by this instrument, shall at once vest in the said EMORY F. STEVENSON as his sole and separate property.
