more particularly described as follows:

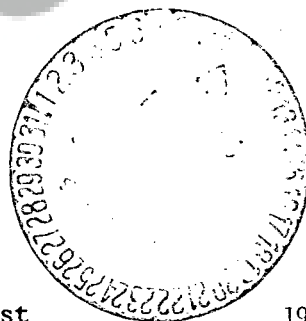
Beginning at the southwesterly corner of Lot 1 of Block B of the Townsite

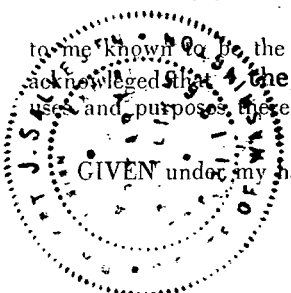
