To the extent that any of the property described herein may be subject to the provisions of the Uniform Commercial Code, this deed of trust is a security agreement, granting to beneficiary, as secured party, a security interest in any such property and the grantor agrees to execute such financing statements as may be required by the beneficiary and pay, upon demand, filing fees for any such financing statements and continuations thereof.

The real property conveyed by this deed of trust is not used principally for agricultural or farming purposes.

THIS DEED IS FOR THE PURPOSE OF SECURING PERFORMANCE of each agreemen, of Grantor herein

contained and payment of the sum of Thirty Four Thousand and No/100

(S 34,000.00) with interest thereon according to the terms of a promissory note of even date herewith, payable to the order of Beneficiary and made by Grantor, and also such further sums as may be advanced or loaned by Beneficiary to Grantor, or any of their successors or assigns, together with interest thereon at such rate as shall be agreed unon.

The Grantor co. enants and agrees as follows

- 1. That he will pay the indebtedness, as hereinbefore provided. Privilege is reserved to prepay at any time, without 1. That he will pay the indebtedness, as nereinbefore provided. Privilege is reserved to prepay at any time, without premium or fee, the entire indebtedness or any part thereof not less than the amount of one installment, or one hundred dollars (\$100.00), whichever is less. Prepayment in full shall be credited on the date received. Partial prepayment, other than on an installment due date, need not be credited until the next following installment due date or thirty days after such prepayment, whichever is earlier.
- 2. Grantor agrees to pay to Beneficiary together with and in addition to the monthly payments of principal and interest payable under the terms of the note secured hereby, on the first day of each month until said note is tully paid.
 - (a) A sum, as estimated by the Beneficiery, equal to the ground rents, if any, and the taxes and special assessments next due on the premises covered by this Deed of Trust, plus the premiums that will next become due and payable on such insurance policies as may be required under paragraph 9 hereof, satisfactory to Beneficiary, Grantor agreeing to deliver promptly to Beneficiary all bills and notices therefor, less all sums already paid therefor divided by the number of months to clapse before one (1) month prior to the date when such ground rents, premiums, taxes and assessments will become Jelinquent, such sums to be held by the Beneficiary in trust to pay said ground rents. rents, premiums, taxes and special assessments.
 - (b) All payments mentioned in the preceding subsection of this paragraph and all payments to be made under the note secured hereby shall be added together and the aggregate amount thereof shall be paid by the Granter each month in a single payment to be applied by Beneficiary to the following Items in the order set forth:
 - ground rents, if any, taxes, special assessments, fire and other hazard insurance premiums;
 interest on the note secured hereby; and
 amortization of the principal of said note.

- (c) Any deficiency in the amount of any such aggregate monthly payment shall, unless made good by the Grantor prior to the due date of the next such payment, constitute an event of default under this Deed of Trust. The arrangement provided for in paragraph 2 is solely for the added protection of the Beneficiary and entoils no responsibility on the Beneficiary's part beyond the silowing of due credit, without intenst, for the sums actually received by it. Upon assignment of this Deed of Trust by the Beneficiary, any funds on hand shall be turned over

to the assignee and any responsibility of the assignor with respect thereto shall terminate. Each transfer of the property that is the subject of this Deed of Trust shall automatically transfer to the Grantee all rights of the Grantor with respect to any funds accumulated hereunder.

- 3. At beneficiary's option grantor will pay a "late charge" not exceeding four per centum (4%) of any installment when paid more than fifteen (15) days after the due date thereof to cover the extra expense involved in handling delinquent payments, but such late charge shall not be payable out of the proceeds of any sale made to satisfy the indebtedness secured hereby, unless such proceeds are sufficient to discharge the entire indebtedness and all proper costs and expenses secured.
- 4. If the total of the payments made under (a) of paragraph 2 shall exceed the amount of payments actually made by Beneficiary for ground rents, taxes, assessments and insurance premiums, such exceed the amount of payments actuary made by Beneficiary on subsequent payments to be made by Grantor. - 5. To keep the property in good order and condition and not to commit or permit any waste thereof. To allow Beneficiary to inspect the property at any time during reasonable hours.
- 6. To complete or restore promptly and in good workmanlike manner any building or improvement which may be constructed, damaged or destroyed thereon, and pay when due all costs incurred therefor, and, if the loan secured hereby or any part thereof is being obtained for the purpose of financing construction of improvements on said property, Grantor
 - To commence construction promptly and in any event within thirty (30) days from the date of the commitment of the Beneficiary, and complete same in accordance with plans and specifications satisfactory to Beneficiary.
 - To complete all buildings or other structures being or about to be built thereon within six (6) months from date
 - To replace any work or materials unsatisfactory to Beneficiary, within fifteen (15) days after written notice to Grantor of such fact,
 - That work shall not cease on the construction of such improvement, for any reason whatsoever for a period of fifteen (15) consecutive days.

The Trustee, upon presentation to it of an affidavit signed by Beneficiary, setting forth facts showing a default by Grantor under this numbered paragraph, is authorized to accept as true and conclusive all faces and statements therein, and to act thereon hereunder.

- 7. Not to remove or demolish any building, improvements thereon or any fixtures or other property or or used in connection with said hadding or inger-vements.
 - 8. To comply with all laws, or linances, regulations, covenants, conditions and restrictions affecting said property
- 9. To keep the buildings, improvements and fixtures now existing or hereafter erected or the mortgaged property insured as may be required from time to time by the Beneficiary against loss by the and other hazards, casualties and contingencies in such amounts and for such periods as may be required by the Beneficiary and well pay promptly, when decaying premiums on such insurance provisions for payment of which has not been made hereinbefore. To appear in and defend any suit, action or proceeding that might affect the value of this security instrument or the security itself or the rights or powers of Beneficiary or Trustee; and should Beneficiary or Trustee elect also to appear in or defend any such action or proceeding the Grantor will, at all times, indemnity from, and, on dem of reimburse Beneficiar, or Trustee for any and all loss, damage, expense or cost, including cost of evidence of title and attorney's fees. ansary out of or mearred at connection with any such suit, action or proceeding, and the sum of such expenditures shall be secured by this Beed of Trust with interest as provided in the note secured hereby and shall be due and payable on demand. Fallure to repay such expenditure or advance and interest thereon within ten (10) days of the mailing of such notice will, at Beneficiary's option, constitute an event of default hereunder; or, Beneficiary may, at its option, commence an action against Grantor for the recovery of such expenditure or advance and interest thereon, and in such event Grantor agrees to pay, in addition to the amount of such expenditure or advance, all costs and expenses incurred in such action, together with a reasonable attorney's fee.
- 13. Upon the request of the Beneficiary, the Grantor shall execute and deliver a supplemental note or notes for the sum or sums advanced by the beneficiary for the alteration, modernization, improvement, maintenance, or repair of said premises, for taxes or assessments against the same and for any other purpose authorized hereunder. Said note or notes shall

be secured hereby on a parity with and as fully as if the advance evidenced thereby were included in the note first described above. - 15. Should Grantor fall to make any payment or to do any act as herein provided, then Beneficiary or Trustee, but without obligation so to do and without notice to or demand upon Grantor and without releasing Grantor from any obligation hereof, may: Make or do the same in such manner and to such extent as either may deem necessary to protect the security hereof, Beneficiary or Trustee being suthorized to enter upon the property for such purposes, commence, appear in and defend any action or proceeding purporting to affect the security hereof or the rights or powers of Beneficiary or Trustee; pay, purchase, contest, or compromise any encumbrance, charge or lien which in the judgment of either appears to be prifor or superior Lereto; and in exercising any such powers, incur any Bability, expend what ever amounts in its absolute discretion it may deem necessary therefor including cost of evidence of title, apploy counsel, and pay his reasonable fees.
- 16. Should the property or any part or appurtenance thereof or right or interest therein be taken or damaged by reason of any public or private improvement, condemnation proceeding, fire, earthquake, or in any other manner, Beneficiary may, at its option, commence, appear in and prosecute, in its own name, any action or proceeding or make any compromise of, settlement, in connection with such taking or damage, and obtain all compensation, a ards or other milet therefor. All such compensation, awards, damages, rights of action and proceeds, including the proceeds of any policies of insurance affecting the property, are hereby assigned to Beneficiary who may, after deducting thereform all its expenses, including attorney's fees, release any monies so received by it, or apply the same on any indebtedness secured hereby or apply the same to the restoration of the property, as it may elect. Grantor agrees to execute such further assignments of any compensation, award, damages, rights of action and proceeds as Beneficiary or Trustee may require.
- 17. By accepting payment of any sum secured hereby after its due date, Beneficiary does not waive its right either to require prompt payment when due of all other sums so secured or to declare default for failure so to pay.
- 18. At any time upon written request of Beneficiary, payment of its fees and presentation of this Deed and the note for endorsement (in case of full reconveyance, for cancellation and retention), without affecting the liability of any person granting any easement or creating any restriction thereon, et of the making of any map or plat of said property; (b) join in Deed or the lien of charge thereof, etd reconvey, without warranty, all we any part of the property. The Grantee in any reconveyance may be described as the "person or persons legally entitled thereto", and the recitals therein of any matters or facts shall be conclusive proof of the truthfulness thereof.
- 19. The collection of rents, issues, and profits, or the proceeds of fire and other ir turance policies or compensation or awards for any taking or damage of the property, and the application or release thereo as aforesaid, shall not cure or waive any default or notice of default hereunder or invelidate any act done pursuant to such notice.
- 20. The Grantor covenants and agrees that he will not execute or file for record any instrument which imposes a restriction upon the sale or occupancy of the secured property on the basis of race, color, or creed. Upon any violation of this undertaking, the Beneficiary may, at its option, declare the unpaid balance of the debt secured hereby immediately due and payable.
- 21. Upon default by Grantor in payment of "ay indebtedness secured hereby or in performance of any agreement hereunder. Beneficiary may declare all sums secured hereby immediately due and payable. No waiver by Beneficiary of any default on the part of Grantor analyse construed as a waiver of any subsequent default hereunder.
- 22. Upon default by Grancor in the payment of any indebtedness secured hereby or in the performance of any agreement contained herein, all sums secured hereby shall immediately become due and payable at the option of the Bereficiary. In such event and upon written request of Beneficiary. Trustee shall sell the trust property, in accordance with the Deed of Trust. Act of the State of Washington, at public auction to the highest bidder. Any person excent Trustee may bid at Trustee's sale. Trustee shall apply the proceeds on the sale as follows: (1) to the expense of sale, including a reasonable distributed to the persons entitled thereto. Trustee shall deliver to the purchaser at the sale its deed, without warranty which shall convey to the purchaser the interest in the property, which Grantor had, or had the power to convey at the time of his execution of this Deed of Trust, and such as he may have acquired thereafter. Trustee's deed shall redie the facts showing that the sale was conducted in compliance with all the requirements of law and of this Deed of Trust, which recital shall be prima facie evidence of such compliance and conclusive evidence thereof in fact or of bona tide purchases and encumbrancers or value. The power of sale conferred by this Deed of Trust and by the Deed of Trust act of the State of Washington is not an exclusive remedy and when not exercised, Beneficiary may foreclose this Deed of Trust as a mortgage. In the event of the conding of such appointment in the mortga, records of the county in which this Deed of Trust is recorded, the successor trustee, shall be vested with all powers of the original trustee. The Trustee is not obligated to notify any party hereto of pending sale under any other Deed of Trust or of any action or proceeding is which Granter, Trustee or Beneficiary shall be a party unless such action or proceeding is brought by the Trustee.
- 23. This Deed shall inure to and bind the heirs, legatees, devisees, administrators, executors, successors, and assigns of the parties here to. All obligations of Grantor hereunder are joint and several. The term "Beneficiary" shall mean the owner and holder, including pledgees, or the note secured hereby, whether or not named as Beneficiary herein. Whenever used, the singular number shall include the plural, the plural the singular, and the use of any gender shall be applicable to all genders. If any of the provisions hereof shall be determined to contravene or be availed under the laws of the State of Washington, such containing the particular provision or provisions of this agreement, but it shall be construed as if not construed and enforced accordingly.
- 21.
