

## PARTIAL RELEASE OF MORTGAGE

343.48 feet; thence on an arc of a 1,390.00 foot radius
curve to the right through an angle of 04°09'16" a
distance of 100.79 feet; thence South 77°27'19" West
162.96 feet; thence on an arc of a 580.00 foot radius
curve to the left through an angle of 25°58'50" to the
Northerly right-of-way of said Evergreen Highway; thence
Northeasterly along said right-of-way to the point of
beginning.
