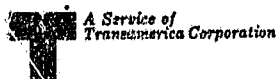

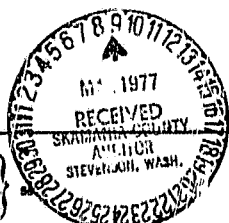
Beginning at a point marking the intersection of the old survey of
