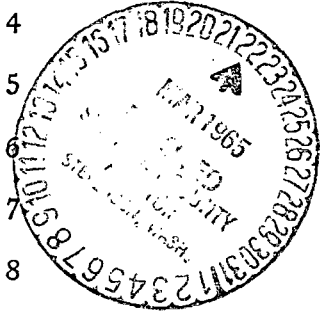

1 Huston, subject to all liens and encumbrances of record.

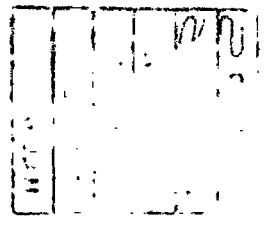
