The budget payments so accumulated may be applied by the Mortgage to the payment of such taxes, assessments, or levies in the amounts shown by, the official statements thereof, and to the payment of insurance premiums in the amount actually prid or incurrent therefor. And such budget payments are hereby pledged to the Mortgagee as collateral security for full performance of this mortgage and the note secured hereby and the Mortgagee may, at any time, without notice, apply said budget payments upon any sums delinquent upon said note or under the terms of this mortgage. mortgage.

In any action brought to foreclose this mortgage or to protect the ilen hereof, the Mortgagee shall be entitled to recover from the Mortgage'rs a reasonable attorney fee to be allowed by the court, and the reasonable cost of searching the records and obtaining abstracts of title or title reports for use in said action, and said sums shall be secured by this mortgage. In such foreclosure action a deficiency judgment may be entered in favor of the Mortgage, and a receiver may be appointed at the Mortgage's request to collect the rents, issues and profits from the mortgaged premises.

And it is further covenanted and agreed that the owner and holder of this mortgage and of the promissory note secured bereby shall have the right, without notice, to present to any person liable for said mortgage indebtedness, any extension of time for payment of all or any part thereof, without in any way affecting the personal liability of any party obligated to pay such indebtedness.
