(Leasehold Interest)

WHEREAS, the State of Washington, Department of Natural Resources, did by a certain loase, Lease No. 58985, bearing date of August 11, 1970, as amended by document dated February 10, 1972, as authorized under RCW 79.01.096, demise and lease for purposes stated in its bid for develop ant and ace units of Water Front Recreation Inc., a Washington Corporation, all is the premises hereafinafter described, all as located in the Cu tourise, 5° to of Mashington, to wit:

MHEREAS, the term of said lease is for a period of fifty-five (55) years from June 1, 1970 to June 1, 2025, subject to a renewal as provided by law. Tater "ront Recreation, Inc., a Washington Corporation, is to pay to the State of W. Ington such sums at such times at a place designated, all in accordance with the terms of said Lease No. 58985 held in the office of the Department of Natural Resources, State of Washington, and as recorded under Auditor's File No. 72521, records of Skamania County, Washin, on; and

WHEREAS, in accordance with the terms of the lease and the development plan submitted to the State of Washington, the property herein described is not used principally for agricultural or farming purposes; and

WHEREAS, Water Front Recreation, Inc. has submitted, and approved, and recorded in the Office of the Auditor of Skamania County, Washington, a Plat and Survey of the above described property entitled "Water Front Recreation, Inc." dated May 16, 1974, on file and of record under Auditor's File No. 77323, at page 449 of Book "J" of Miscellaneous Records of Skamania County, Washington, together with appartenant easement as established in writing on said plat for the joint use of the area shown as roadways on the plat, WATERFRONT REGREATION, INC.

are entering into this portrage to First Federal Savines and loan Association of Vancouver to secure an indebtodness, to First Federal Savines and Loan Association of Vancouver of money being loaned by it and borrowed by the pertugger to construct a single farily home on lot 135 as shown on the above referred to Plut and Survey, which is a part of the above described plut and survey on record in the office of the Auditor of Skamania County, Washington, and within the metes and bounds of the legal description in Lease No. 58985 heretofore described.

WHEREAS, Water Front Recreation, Inc. did with approval of the State of Washington and in conformance with the primary least heretof re described, make, execute and deliver to the mortgager herein a document entitled "Cabin Site Lease", a copy of which is hereto attached and incorporated herein as if set out in full.

NOW THEREFORE, to secure the just indebtedness of the mortgagor, to First Federal Savings and Loan Association of Vancouver, WATERFRONT RECREATION, INC.

make the covenants hereinafter stated and mortgages to first Pederal Savings and Loan Association of Vancouver, a corporation, mortgagee, their cabin site leasehold interest, on the following real property located in the County of Skamania, Statu of Washington, to wit:

The lion of this mortgage shall also extend over and to an shall cover any future interest that the mortgager may acquire in the sai, real property, and also all future equipment, appurtenances, or fixtures, attached to or becoming a part thereof, as such equipment and appurtenances are hereinafter described, and also the rentals, issues and profits of the portgaged property.

Also, this mortgage lien shall continue in force and exist as security for any and all other advances which may hereafter be made by the mortgage to the mortgager, and shall continue in force and exist as security for any debt owing, or hereafter to become owing, by the mortgager to the mortgage.

The mortgagors convenant that they are the owners of the leasehold interest in the above described premises; that the same are now free of encumbrance; that this mortgage is for the benefit of the mortgage for its proper use and benefit for and during all the rest, residue and remainder of said term of years yet to come and unexpired; subject, nevertheless, to the rents, covenants, conditions,

and provisions in the indenture of lease mentioned from the State of Mashington; that by separate document they have assigned with consent of the State of Washington all of their right, title and interest in and to the above described leasehold interest to the mortragee herein as a part of this transaction and contract to better secure the mortgages; that the State of Mashington has consented to the mortgagor entering into this transaction; that they will keep the buildings and other destructible property covered by this mortgage insured against loss by fire, in a sum at least qual to the mortgagee's appraised value thereof; such insurance contract shall be issued by a responsible insurance company and the policy evidencing the same shall be delivered into the nossession of the mortgagee. The said policy shall be endorsed by the nortgagor and shall contain an appropriate clause providing that the loss thereunder, if any, shall be payable to the mortgagee, in accordance with its interest at the time of loss. The mortgagor further covenants that they will pay promptly all premiums on such insurance; and that they will pay promptly before delinquency any and all installments of taxes, special assessments and other governmental levies, together with all rentals and payments required of them under the cabin site lease hereto attached, which may hereafter be levied against or become a lien upon this mortraged property; that they will keep the buildings and appurtenances on the said property in a good state of repair, all to the effect that the value of the said property shall not be impaired during the life of this mort mage.

The mortragor further covenants and agrees that any and all electric wiring, furnace and heating systems, including water heaters, burners, fuel storage bins and tanks, the plumbing, ventilating, water and irrigation systems, the screens and screen dors, built-in mirrors, cumboards, cabinets, and other things of like or similar character, and all trees and gardom shrubs, shall be considered as, and in case of foreclosure of this mortrage, adjudicated to be, fixtures, and a part of the mortgaged property, and shall pass to the purchaser at any execution sale resulting from a foreclosure of this mortgage, and in the absence of foreclosure, and during the life of this mortgage, none of such items shall be removed, nor their value in any way impaired, by the mortgage or their successor. In event Section 5,09 of the master lease referred to below is invoked for the protection of the mortgage, the above items shall be considered in the same manner as it his nortgage that been foreclosed, or in the event mortgage obtains possession through any other means the items above referred to shall be considered in like manner.

The portracer further covenants and agrees that the loan secured by this nortrace is made upon the personal character and interrity of the mortgager, as well as upon the security offered, and that therefore they will not convey this nortraced property, or any interest therein, without the consent of the orteace, and if any such consent is given, and any such conveyance made, the parchaser or grantee will, personally, assure and agree to pay this debt.

If the Lessee becomes insolvent or bankrupt, or if a receiver is appointed, the State may cancel, at its ontion, the lease unless the lease has been used as collateral with the State's consent. If the Lessee should default in a payment to the lending agency, the State, upon request by the Lender, shall assign the lease to the lending agency who may, thereafter, either operate the leased site or, with the approval of the State, assign the lease.

or otherwise, prior to the lease termination of this lease, by cancellation or otherwise, prior to the lease termination date, shall not serve to cancel approved sub-leases, nor derrogate from the rights of the lienholders of record, but shall operate as an assignment to the State of any and all such sub-leases, but shall operate as an assignment of the State to receive all sub-lease together with the unrestricted right of the State to receive all sub-lease payments therein provided for from the date of said assignment. Upon termination of this lease, by cancellation or otherwise, prior to the termination date of said lease, the Lessee shall have no claim to sub-lease payments and/or sub-lease improvement values herein contained."

Or mortgagee may immediately foreclose this mortgage and the property covered by this mortgage may be sold as provided by law, and in event of such assignment or foreclosure sale or the invoking of any other remedy provided by law by the mortgagee, shall be a perpetual bar, both in law and equit, against the mortgager and against all persons claiming or to claim the premises, or any part thereof by, from, through or under the mortgager or any of them.

At the election of mortgagee, if it so desires, if mortgager shall fail to pay any installment of tuxes, special assessments or other governmental levies that may become due, or if they shall fail to purchase and pay the premium on any policy of insurance, then the mortgagee may pay or advance such sums as may be necessary to pay such tax assessments, or governmental levy, or such insurance premium, and the amount so paid shall be added to and become a part of the debt secured hereby.

The mortgagor further agrees that if they should fail to make the payments as herein provided, or should they fail to perform any other covenant or condition of this contract, and in case of a foreclosure action, they agree to pay, in addition to the principal and interest then due, and in addition to any items of expense as are above mentioned, such sum as the court may adjudge reasonable as attorney's fees in such foreclosure action.

The mortgagor further represents that the funds loaned by the mortgaged and secured by this mortgage are to be used for improvements of the mortgaged premises.
