## COMMUNITY PROPERTY AGREEMENT

THIS AGREEMENT made and entered into this 4th day of August, 1947, by and between Robert Roe Norton, party of the first part, and Hazel G. Norton survives, the whole of said property hereinbefore mentioned, together with any property by them hereafter acquired, shall at once vest in the said Hazel G. Norton, in fee simple as her a sole and separate property; and in the case of the death of the said Hazel G. Norton, leaving the said Robert Roe Norton surviving, the whole of said property hereinbefore mentioned, together with any other property by them hereafter acquired, shall at once vest in the said Robert Roe Norton, in fee simple, as his sole and separate property.
