WILSON at 4941 Cora Street, Portland, Oregon, the sum of FIFTEEN THOUSAND FOUR HUNDRED FIFTY-ONE AND 47/100 (\$ 15,451.47), in lawful money of the United States, with interest thereon at the rate of Eight Percent (8%) per annum from date until paid, in monthly installments of not less than \$170.00, including interest at the rate of Eight Percent (8%) per annum; the first payment to be made on the 10th day of March, 1978, and a like payment on the same day of every month thereafter, until the whole sum,

principal and interest, has been paid. If any installment is not so paid, the whole sum of principal and interest shall become immediately due and collectible at the option of the holder of this note. In case suit or action is instituted to collect this note, I promise to pay such additional sum as the trial court may adjudge reasonable as attorney's fees in said suit or action, and any appellate court upon appeal of such suit or action.
