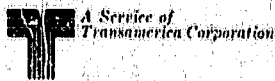

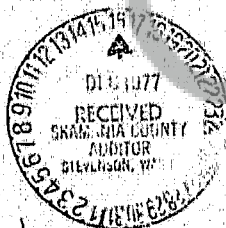

A TRACT OF LAND IN THE EAST HALF OF SECTION 15, TOWNSHIP 4 NORTH, RANGE 7 EAST OF THE W.M., LYING NORTHERLY OF THE WIND RIVER HIGHWAY AND MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT SOUTH 09° 22' WEST 2,030.1 FEET FROM THE SECTION CORNER COMMON TO SECTIONS 10, 11, 14, and 15 OF SAID TOWNSHIP AND RANGE, SAID POINT BEING MARKED BY AN IRON PIPE ON THE WESTERLY RIGHT OF WAY LINE OF THE COUNTY ROAD KNOWN AND DESIGNATED AS THE LEEYE ROAD; THENCE WEST 450 FEET TO AN IRON PIPE; THENCE SOUTH 15° 45' EAST 1,283.1 FEET TO AN IRON PIPE SET IN THE NORTHERLY RIGHT OF WAY LINE OF THE WIND RIVER HIGHWAY SAID POINT BEING THE TRUE POINT OF BEGINNING; THENCE SOUTH 57° 09' EAST ALONG THE NORTHERLY RIGHT OF WAY LINE OF SAID HIGHWAY 118.5 FEET TO AN IRON PIPE SET AT THE INTERSECTION OF THE NORTHERLY RIGHT OF WAY LINE OF SAID HIGHWAY AND THE WESTERLY RIGHT OF WAY LINE OF THE LEEYE ROAD; THENCE NORTHERLY ALONG THE WESTERLY RIGHT OF WAY LINE OF THE LEEYE ROAD 574.4 FEET; THENCE WEST AT RIGHT ANGLES TO THE WESTERLY LINE OF LEEYE ROAD TO A LINE DRAWN NORTH 15° 45' WEST FROM THE TRUE POINT OF BEGINNING; THENCE SOUTH 15° 45' EAST TO THE TRUE POINT OF BEGINNING.
