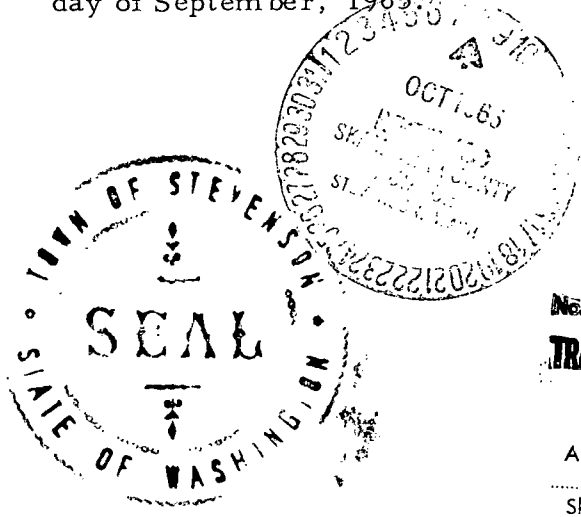
DEED

KNOW ALL MEN BY THESE PRESENTS: That the Grantor, THE TOWN OF STEVENSON, a municipal corporation, organized and existing under the laws of the State of Washington, does hereby convey and quit claim unto the PORT OF SKAMANIA COUNTY, a municipal corporation, organized and existing under and by virtue of the laws of the State of Washington, the Grantee, the following described real estate situated in the County of Skamania, State of Washington, to-wit:

Commencing at the Southeast corner of Block Two (2) of Riverview Addition to the Town of Stevenson; thence North 55°30' East 40 feet to the initial point of the tract to be conveyed; thence North 34°30' West 118 feet; thence North 55°30' East to the center of Kanaka Creek; thence following the center of Kanaka Creek in a South and Easterly direction to the Southeast corner of that tract of land conveyed to A. Salsate by deed recorded at page 180, Book "L" of Deeds, records of Skamania County, (said point being South 31°19' East of Station 1660 plus 17.1 of the S. P. and S. Railway); thence South 31°19' East along the center of an old tram road to the meander line of the Columbia River; thence Westerly along said meander line to a point South 34°30' East of the initial point; thence North 34°30' West to the place of beginning, containing two acres, more or less.

This Deed and conveyance is made pursuant to Resolution No. 1-65 of the Town Council of the Town of Stevenson and also pursuant to that certain Decree entered in the Superior Court of the State of Washington in and for the County of Skamania, in Cause No. 4415-C on the 16th day of September, 1965.

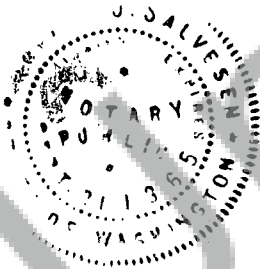
