

E A S E M E N T

The Grantors, ALBERT AALVIK and LUCILLE AALVIK, husband and wife, for valuable consideration received, do hereby grant, bargain, and sell and convey unto CROWN ZELLERBACH CORPORATION, a Nevada corporation, Grantee, its successors and assigns, a permanent, nonexclusive, assignable easement for the use of a road, on, over and across the following described real property situated in Skamania County, Washington, to-wit:



Existing logging roads as now located over and across the NE $\frac{1}{4}$ of Section 14 and the SE $\frac{1}{4}$ of Section 11, all in Township 3 North, Range 7 East, W.M., Skamania County, Washington, as indicated in red on the attached plats, marked "Exhibit A" and "Exhibit B", attached hereto and by this reference made a part hereof.

The Grantors, for themselves and their heirs, successors and assigns, reserve the right to use the above described property in common with the Grantee for any purpose which does not unreasonably interfere with the use by the Grantee, including, but not in any way limited to road use in common with the Grantee and its successors and assigns, and rights of access, crossings, and exits. However, each party using said road or easement shall pay a fair share of the costs of maintenance of the same, in proportion to its use thereof.

The terms, conditions and covenants herein shall be binding upon and inure to the benefit of the parties hereto, and their respective heirs, successors and assigns, and shall run with the land over which said easement crosses.

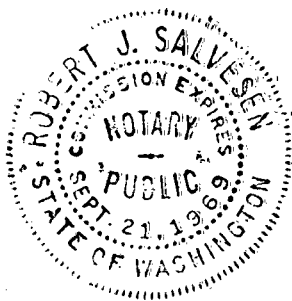

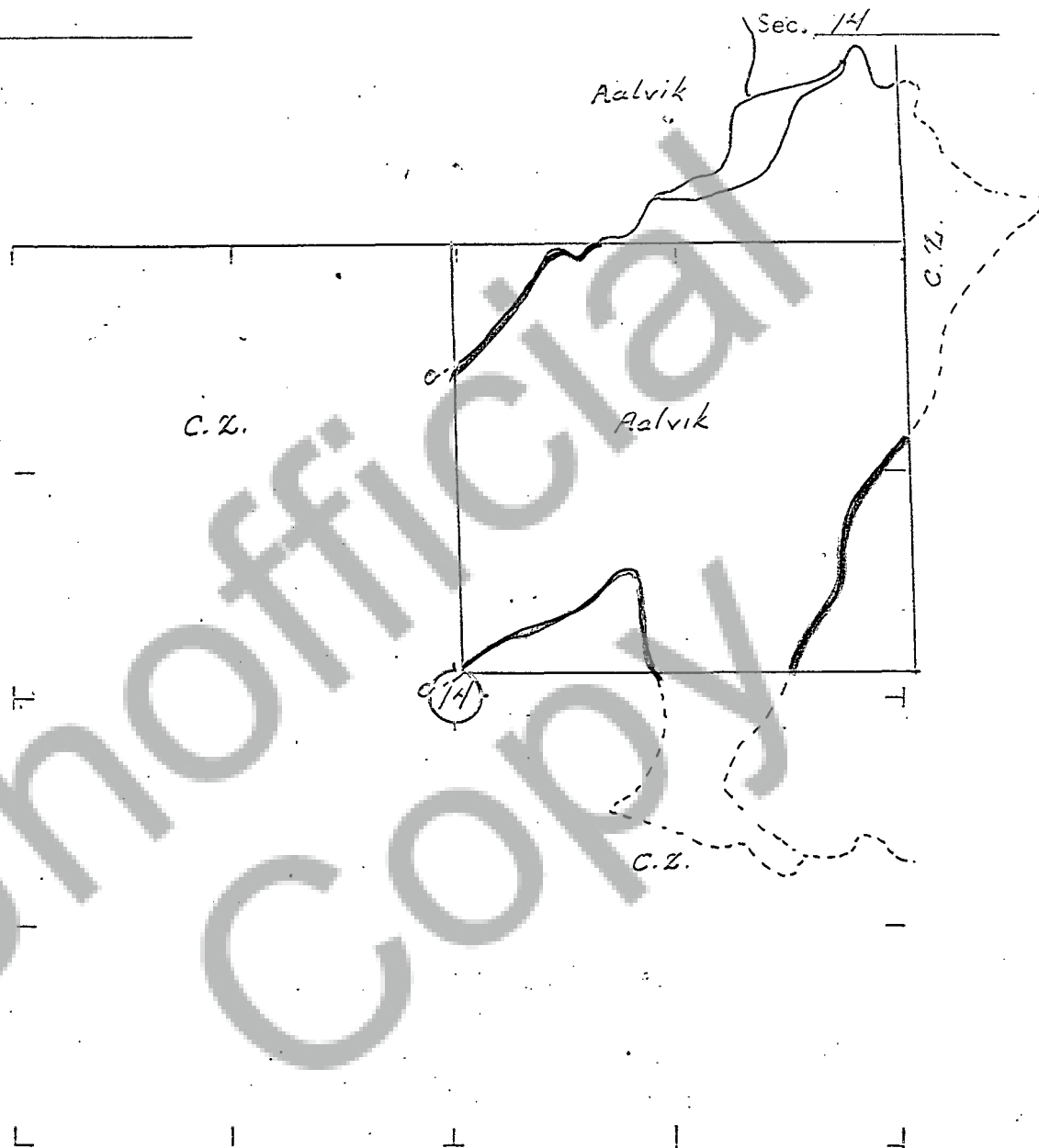
