in hand paid, convey s and warrant s to Skamania County, Washington

the following described Real Estate A right of way for the relocation of the County Road known as the Cooks-Underwood Road, being in the S.E.  $\frac{1}{4}$  of the S.E.  $\frac{1}{4}$  of Section 27, Township 3 North, Range 9 E.W.M. as shown on plans on file in Office of County Engineer dated May 12, 1965 and more particularly described as follows: Areas hereafter described southeasterly from the centerline of the County Road as relocated in 1965 and shown on above referenced plans. Said centerline being described as follows: Beginning at a point 81.58 feet West and 10.84 feet North of the S.W. Corner of the S.E.  $\frac{1}{4}$  of the S.E.  $\frac{1}{4}$  of said Section 27, said point being designated as Station 14 + 70.67. Thence along a 6° 0' curve to the right whose center bears S 32° 34' E a distance of 349.72 feet; thence N 78° 25' E 534.24 feet to the P.C. of a 6° 0' curve to the left; thence along said curve 655.4 feet more or less to an intersection with the Section line between Sections 26 and 27. The described areas are southeasterly from the described centerline as follows: From Station 14 + 70.67 to Station 16 + 00, 30 feet on right; Station 16 + 00 to Station 18 + 00, 75 feet on right; Station 18 + 00 to Station 19 + 25, 60 feet on right; Station 22 + 00 to Station 24 + 50, 160 feet on right; Station 24 + 50 to Station 25 + 00, 120 feet on right; Station 25 + 00 to intersection with the existing County Road, 60 feet on right. Also a tract Northwesterly from described centerline and Southeasterly from existing road between approximate Stations 22 + 60 and Station 24 + 70. Excepting existing County Road. Described right of way contains 1.54 acres more or less.

Other considerations are: Skamania County will vacate existing road and level the area. Surplus material from roadway excavation will be used to create as large a level area as possible adjacent to vacated roadway. Also a roadway will be left for access.
