The mort agor agrees that if the mortgage indebtedness is evidenced by more than one note, the mertgage may tredit payments received by it upon any of said notes, or part of any payment on one note and part on another, as the mortgage may elect. The mortgage exercises the right to refuse payments in excess of those specified in the note agreement or payment of the debt in whole, unless otherwise provided in the note or notes given with this mortgage.

The mortgager shall not move or after any of the structures on the mortgaged premises without consent of the mortgage; all improvements placed thereon shall become a part of the real property mortgaged herein.

Should the mortgager default in any of the foregoing covenants or agreements, then the mortgage may perform the same and may pay any part or all of principal and interest of any prior incumbrances or of insurance premiums or other charges secured hereby, and any amounts so paid, with interest thereon at the highest legal rate from date of payment shall be repayable by the mortgager on demand, and shall also be secured by this mortgage without waiver or any right or other charges retrieved of any of the covenants hereof. The mortgagee shall be the sole judge of the validity of any tax, successment or lien assetted against the property, and payment thereof by the mortgage shall establish the right to recover the amount so paid with interest.
