I, JOSEPHINE A. MEYER, being first duly sworn, on oath, depose and state:

1. This affidavit is for the purpose of supplying information for record pertaining to that certain Community Property Agreement executed by Cornelius Meyer and Josephine A. Meyer, husband and wife, which agreement was dated January 6, 1966, and which was recorded on _____ and also for the estate of Cornelius Meyer, deceased, one of the parties to said agreement. It is intended that the statements set forth herein shall be considered representations of fact which may be relied upon by all parties dealing with the real estate described on Exhibit "A" attached and made a part hereof.

2. Cornelius Meyer died on February 17, 1966, in Portland, Multnomah County, Oregon.

3. The parties to the Community Property Agreement referred to above entered into no subsequent wills or agreements which would have the effect of abrogating or nullifying the above mentioned Community Property Agreement.

4. The community estate of the decedent and Josephine A. Meyer was of the net appraised value of Nine Thousand Six Hundred Fifty and 53/100 (\$ 9,650.53), including the real property with the value as listed on Exhibit "A".

5. The decedent left no separate estate.

6. All obligations of the community owing at the date of death of decedent have been paid in full, and all expenses of last sickness and for funeral services have been paid.

7. Attached hereto marked Exhibit "B" is the release of the Inheritance Tax Division of the Washington State Tax Commission.
