MORTGAGE

Parcel A: That portion of the northwest quarter of the southwest quarter of Section 36, Township 3 north, Range 7 East of the W.M., more particularly described as follows: Beginning at the northwest corner of the northwest quarter of the southwest quarter of Section 36; thence south along the west line thereof to a point 20 feet south of the south bank of Rock Creek; thence easterly and southerly on a line parallel with and 20 feet southerly from said south bank to the south line of the northwest quarter of the southwest quarter of the said section 36; thence east to the middle of Rock Creek; thence northerly and westerly following the middle of said Creek to its intersection with a line drawn parallel with and distance 5 chains from the east line of the northwest quarter of the southwest quarter of said Section 36; thence north to the north line of the northwest quarter of the southwest quarter of said section 36; thence west 15 chains, more or less, to the Point of Beginning.
