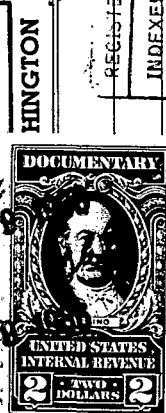
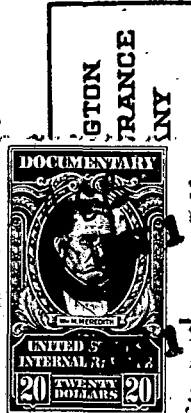

in hand paid, conveys and warrants to ALLEN C. CHISHOLM and NADINE M. CHISHOLM, husband and wife

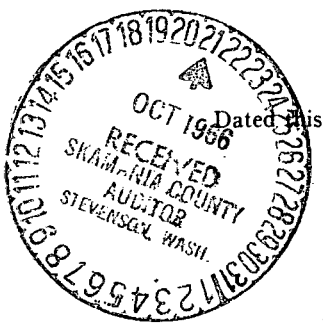
the following described real estate, situated in the County of Skamania, State of Washington:

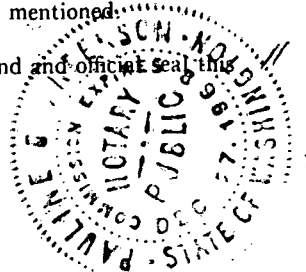
