Additional right of way as required for the construction of the Cook-Underwood Road in the S.W. ¼ of Section 26, Township 3 North, Range 9 E.W.M. as follows: A strip of land lying easterly and contiguous to the County Road known and designated as Cook-Underwood Road being more particularly described as follows: That land lying easterly of the centerline of Cook-Underwood Road and lying westerly of a line drawn from a point lying 30 feet distant easterly and radially from Station 50 + 00 on proposed centerline to a point lying 50 feet distant and radially from Station 50 + 50 on proposed centerline. Thence following a line drawn 50 feet distant when measured radially and/or perpendicular to proposed centerline to Station 51 + 00. Thence to a point lying 30 feet distant and perpendicular to Station 51 + 50 on proposed centerline. Also a strip of land lying westerly and contiguous to the Cook-Underwood Road being more particularly described as that land lying westerly of the Cook-Underwood Road and easterly of a line drawn from a point lying 30 feet distant westerly when measured radially from Station 50 + 00 of proposed centerline to a point 40 feet distant when measured radially from Station 50 + 50. Thence following a line drawn 40 feet distant when measured radially and/or perpendicular to proposed centerline to Station 51 + 50. Thence easterly to a point lying 30 feet distant when measured perpendicular to proposed centerline, at Station 52 + 00.

All reference to proposed centerline refer to plan dated September, 1966 and on file in the Office of the County Engineer, in file drawer N, Folder 1, Sheet 11.
