INTERLOCUTORY JUDGMENT OF DIVORCE
(Default)

17 This cause came on to be heard before Honorable GEORGE M. DELL
18 Judge presiding in Department SOUTH "B" on the 28th day of December, 1966,
19 MYRON BLUMBERG, appearing as attorney for plaintiff, and it appearing that
20 defendant was duly served with process on October 8, 1966 and has not appeared
21 or answered the complaint, and that the default of defendant has been entered;
22 and evidence having been introduced on the part of plaintiff, and said cause
23 having been duly submitted to the Court for decision:

25 IT IS ADJUDGED:

26
27 1. That plaintiff is entitled to a divorce from defendant; that when
28 one year shall have expired from the date of service of copy of summons and
29 complaint upon the defendant a final judgment dissolving the marriage between
30 plaintiff and defendant be entered, and at that time the Court shall grant such
31 other and further relief as may be necessary to complete disposition of this
32 action.

1 3. The following described property is the community property of
2 plaintiff and defendant and is hereby awarded to plaintiff as her sole and
3 separate property:

4 (a) Lot 20 of Blossom Tract, in the City of Long Beach,
5 County of Los Angeles, State of California, as per map recorded
6 in Book 8, Page 73 of Maps in the office of the County Recorder,
7 Los Angeles County, California - (Also known as 2324, 2326 and
8 2328 East Fifth Street, Long Beach, California).

10 (b) All of the interest of "Seller" in a real estate contract be-
11 tween Lorin Burgess and Nancy Burgess, "Seller", and Melvin Evans,
12 Charlotte Evans, Edward C. Hewitson and Mary Jane Hewitson, as
13 "Purchaser", recorded August 31, 1959 in Book 46, Skamania County
14 Deed Records at page 296, covering real property in Skamania County,
15 Washington; said Seller's interest having been assigned to Robert
16 Slothower and Madiyn Slothower by assignment dated September 3, 1959,
17 recorded September 8, 1959 in Book 46, page 301, Skamania County
18 Deed Records, Skamania County Washington; said Slothowers' interest
19 having been assigned to Walter G. Colson and Dessa M. Colson, and
20 said real estate contract having been amended by Agreement dated
21 April 30, 1960, recorded July 14, 1960 in Book 47, Pages 326 to 329,
22 Skamania County Deed Records, Skamania County, Washington; and
23 said Colsons' interest having been assigned to George Bunt and Betty
24 Jean Bunt (defendant and plaintiff herein, respectively) by assignment
25 dated July 7, 1960, recorded July 14, 1960 in Book 47, Page 330,
26 Skamania County Deed Records, Skamania County, Washington; to-
27 gether with all of the interest of said George Bunt and Betty Jean Bunt
28 in the real property described in the Warranty Deed recorded July 14,
29 1960, in Book 47, Pages 331 and 332, Skamania County Deed Records,
30 Skamania County, Washington.

3. The following described property is the community property of plaintiff and defendant and is hereby awarded to defendant as his sole and separate property:

(a) 1967 Ford Station Wagon, California License No. NHV 788,

(b) The North 45 feet of Lot 23 in Block "H" of Bay View Heights Tract, in the City of Long Beach, County of Los Angeles, State of California, as per map recorded in Book 3, Page 59 of Maps, in the office of the County Recorder of said County. - false known as 207-207-1/2 Reswell Avenue, Long Beach, California.)

4. The custody of the three minor children of the parties, GLORIA JEAN BUNT, born March 18, 1946, RANDY DEAN BUNT, born February 21, 1944, and LINDA LOU BUNT, born December 18, 1947, is awarded to

1 plaintiff, subject to the right of defendant to visit with said children at reason-
2 able times; provided, however, that such visitation right may be exercised
3 only if defendant has not consumed alcoholic beverages at any time during the
4 previous twenty-four hour period, and provided further that defendant gives
5 at least one day's notice to plaintiff of his intention to exercise such right of
6 visitation. The Court reserves jurisdiction to determine the amount and
7 manner of payment to be made by defendant to plaintiff toward the support of
8 the aforesaid minor children of the parties.

9
10 5. Defendant shall pay directly to plaintiff, as alimony, \$1.00 per
11 year, payable on the first day of each year, commencing the first day of
12 January, 1967, and continuing thereafter on the first day of each year until
13 further order of court.

15 THE CLERK IS ORDERED TO ENTER THIS DECREE.
