

WARRANTY DEED

The Grantor, SCHOOL DISTRICT NO. 301, a municipal corporation of Skamania County, Washington, and the successor to School District No. 10, for and in consideration of the sum of Three Thousand Five Hundred and Three and 37/100 (\$3,503.37) Dollars in hand paid, conveys and warrants to ROBERT W. BARNES and BLANCHE A. BARNES, husband and wife, the following described real property located in Skamania County, State of Washington:

Beginning at the northeast corner of Section 34, Township 3 North, Range 8 E.W.M., thence north 89° 30' west along the north line of the said Section 34 a distance of 64.25 feet to the initial point of the tract hereby described; thence in an easterly direction following the north lines of Section 34 and 35, Township 3 North, Range 8 E.W.M., a distance of 124 feet; thence south to the northerly line of State Highway No. 8 as the same existed prior to January 25, 1955; thence north 64° 39' west following the northerly line of the said State Highway No. 8 to a point due south of the initial point; thence north to the initial point; said tract being the easterly 124 feet of Lot 8 of the vacated plat of Home Valley lying northerly of said State Highway No. 8; EXCEPT that portion thereof and rights of limited access conveyed to the State of Washington for Primary State Highway No. 8 by deed dated January 25, 1955, recorded February 18, 1955, under Auditor's file number 48266 at page 228 of Book 39 of Deeds, Records of Skamania County, Washington;

TOGETHER WITH all water rights appurtenant to the above described real property.

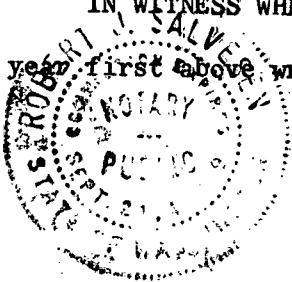
