



LEGAL DESCRIPTION ATTACHED AND MADE A PART HERETO:

A portion of the South half of the Southwest quarter of Section 34, Township 2 North, Range 5 East, W. Lamette Meridian, Skamania County, Washington, described as follows:

BEGINNING at the Southeast corner of the Southeast quarter of the Southwest quarter of Section 34; thence North 89° 30' 12" West along the South line thereof, 738.47 feet to the center line of a 60 foot road easement (known as the Sprinkel Road, private);

THENCE North 08° 20' 00" West, 277.50 feet to a 1/2" iron rod;

THENCE Leaving center line said right of-way line North 63° 00' 00" East, 895.40 feet to the East line of said Southeast quarter of the Southwest quarter;

THENCE South 01° 03' 40" West, 880.17 feet to the POINT OF BEGINNING.

Containing 10.2 acres more or less.

SUBJECT TO easements and restrictions of record.

TOGETHER WITH AND SUBJECT TO that certain road easement as described in Volume 74 Page 57C, Skamania County Deed Records.
