CHARLES L. HAUG and DELORES E. HAUG, husband and wife,

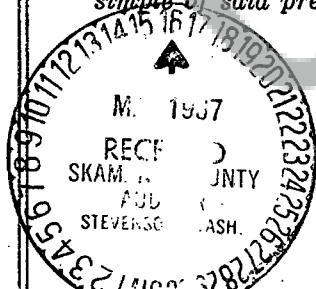
parties of the second part, have GRANTED, BARGAINED, and SOLD, and by these presents do
