EASEMENT FOR CONSTRUCTION AND

MAINTENANCE OF WATER MAIN

THIS INDENTURE is given by Harley A. Ternahan, hereinafter referred to as the "Grantor", to Public Utility District No. 1 of Skamania County, Washington, hereinafter referred to as the "Grantee", for and in consideration of services rendered and to be rendered by the Grantee to the Grantor and the other mutual covenants and considerations hereinafter set forth;

WITNESSETH

That for and in consideration of the sum of Three Hundred Dollars (\$300.00) cash in hand paid, the receipt of which is hereby acknowledged, the Grantors do hereby bargain, sell, convey, transfer and deliver to the Grantee a permanent easement and right of way, including the perpetual right to enter upon the real estate hereinafter described, at any time that the Grantee may see fit and construct, maintain and repair underground pipelines and/or mains for the purpose of conveying water over, across, through and under the property hereinafter described together with the right to excavate and refill ditches and/or trenches for the location of said pipelines and/or mains and the further right to remove trees, bushes, undergrowth and other obstructions interfering with the location, construction and maintenance of said pipeline and/or mains.

The land affected by this grant of easement and right of way is located in the County of Skamania, State of Washington, and is more particularly described as follows:

The South Half of the Southwest Quarter of the Northwest Quarter $(S_{\frac{1}{2}}^{\frac{1}{2}} SW_{4}^{\frac{1}{2}} NW_{4}^{\frac{1}{2}})$ of Section 21, Township 3 North Range 10 East W. M.

The easement and right of way hereby granted covers a strip of land 20 feet in width over and across and located in the Westerly 30 feet of the above described land together with a water reservoir overflow and drainage easement across the above described land.

This easement and right of way given with respect to it are given to the Grantee, its successors and assigns, in perpetuity.

As a part of the consideration for this grant, the Grantor hereby releases any and all claims for damages, from whatsoever cause incidental to the exercise of the rights herein granted.
