JOHNSON and HELEN E. JOHNSON, husband and wife, the Grantees, a permanent easement of right of way to pass over and across the following described real estate in Skamania County, Washington, to-wit:

Beginning at a point on the East line of Section Twenty-seven (27), Township Three (3) North, Range Nine (9) East of the Willamette Meridian, 1870.31 feet South of the one-quarter ($\frac{1}{4}$) corner between Sections Twenty-six (26) and Twenty-seven (27), said point also being 126.44 feet North $81^{\circ}20'$ West from the point of beginning of a curve southwesterly on the County Road designated as Station 32 plus 27.96; thence South 40 feet; thence South $81^{\circ}20'$ East 120 feet more or less to the East boundary of the County Road; thence Northeasterly along the East boundary of the County Road 40 feet more or less to a point which is South $81^{\circ}20'$ East 126.44 feet from the point of beginning; thence North $81^{\circ}20'$ West 126.44 feet to the point of beginning.

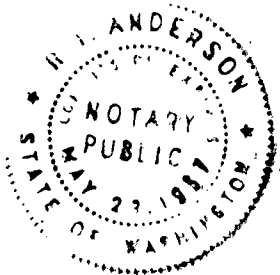

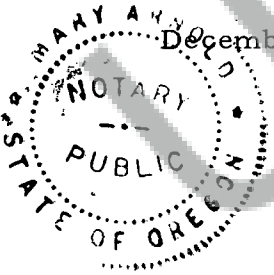
