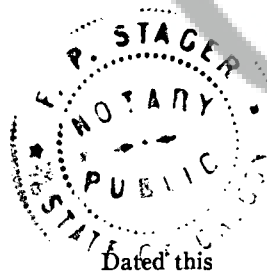
THE GRANTOR DEAN COLVIN AND EDNA COLVIN, husband and wife,

Beginning at the northwest corner of the Jos. Robbins D.L.C. in Section 27, T. 3, N., R. 8 E. W. M.; thence east 607.8 feet; thence south 01° 51' west 763.5 feet to center of county road known as Berge Road; thence along the center of said road south 64° 35' west 552.8 feet; thence along the center of said road on a 30° curve to the right 90 feet to the west line of the said Robbins D.L.C., thence north along the west line of said Robbins D.L.C. 1,021.4 feet to the point of beginning; ALSO: Government Lots 1, 4, and 8; and the North half of the Northeast quarter (N 1/2 NE 1/4); all in Section 27, T. 3 N., R. 8 E. 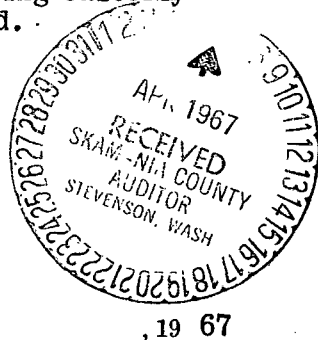
