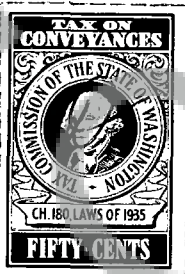
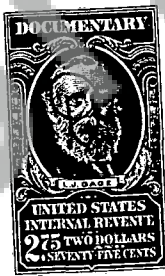
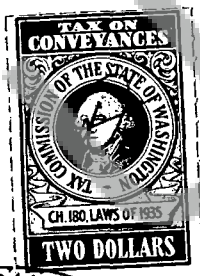

taining 3 acres, more or less.

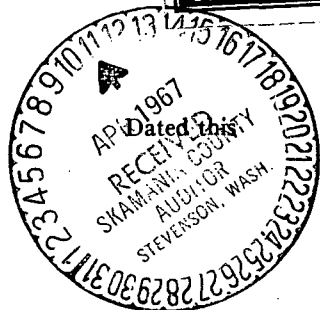
