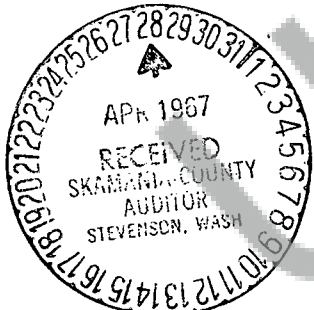
conveys and quit claims to WOODROW TAYLOR

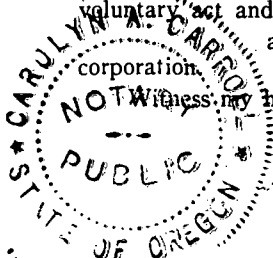
