Being a strip of land lying westerly of and contiguous to the existing county road and easterly of a line drawn parallel to and 30 ft. distant when measured perpendicular and/or radially from the proposed centerline from the South line of Sec. 3 Twn. 1 North, Range 5 E.W.M. to Sta. 16 + 00; thence westerly to a point 40 ft. distant westerly from Sta. 16 + 00; thence parallel to and 40 ft. distant from proposed centerline to Sta. 18 + 00; thence westerly to a point 50 ft. distant from Sta. 18 + 00; thence parallel to and 50 ft. distant from proposed centerline from Sta. 18 + 00 to Sta. 20 + 00; thence easterly to a point 40 ft. distant from Sta. 20 + 00; thence parallel to and 40 ft. distant from proposed centerline from Sta. 20 + 00 to Sta. 22 + 00; thence easterly to a point 30 ft. distant from Sta. 22 + 00; thence parallel to and 30 ft. distant from proposed centerline from Sta. 22 + 00 to approximate Sta. 28 + 10.

Also a strip of land lying easterly of and contiguous to the existing County Road and westerly of a line drawn parallel to and 30 ft. distant when measured perpendicular to and/or radially from the proposed centerline from the South line of said Sec. 3 to Sta. 16 + 00; thence easterly to a point 45 ft. distant from Sta. 16 + 00; thence parallel to and 45 ft. distant from proposed centerline from Sta. 16 + 00 to Sta. 18 + 00; thence easterly to a point 65 ft. distant from Sta. 18 + 00; thence parallel to and 65 ft. distant from proposed centerline from Sta. 18 + 00 to approximate Sta. 20 + 10.

Also a strip of land lying easterly of and contiguous to the existing County Road and westerly of a line drawn parallel to and 35 ft. distant from proposed centerline from approximate Sta. 27 + 70 to South right of way line of S.S.H. 120, all as shown on attached map. 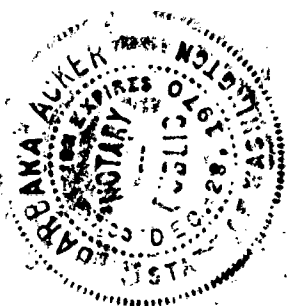

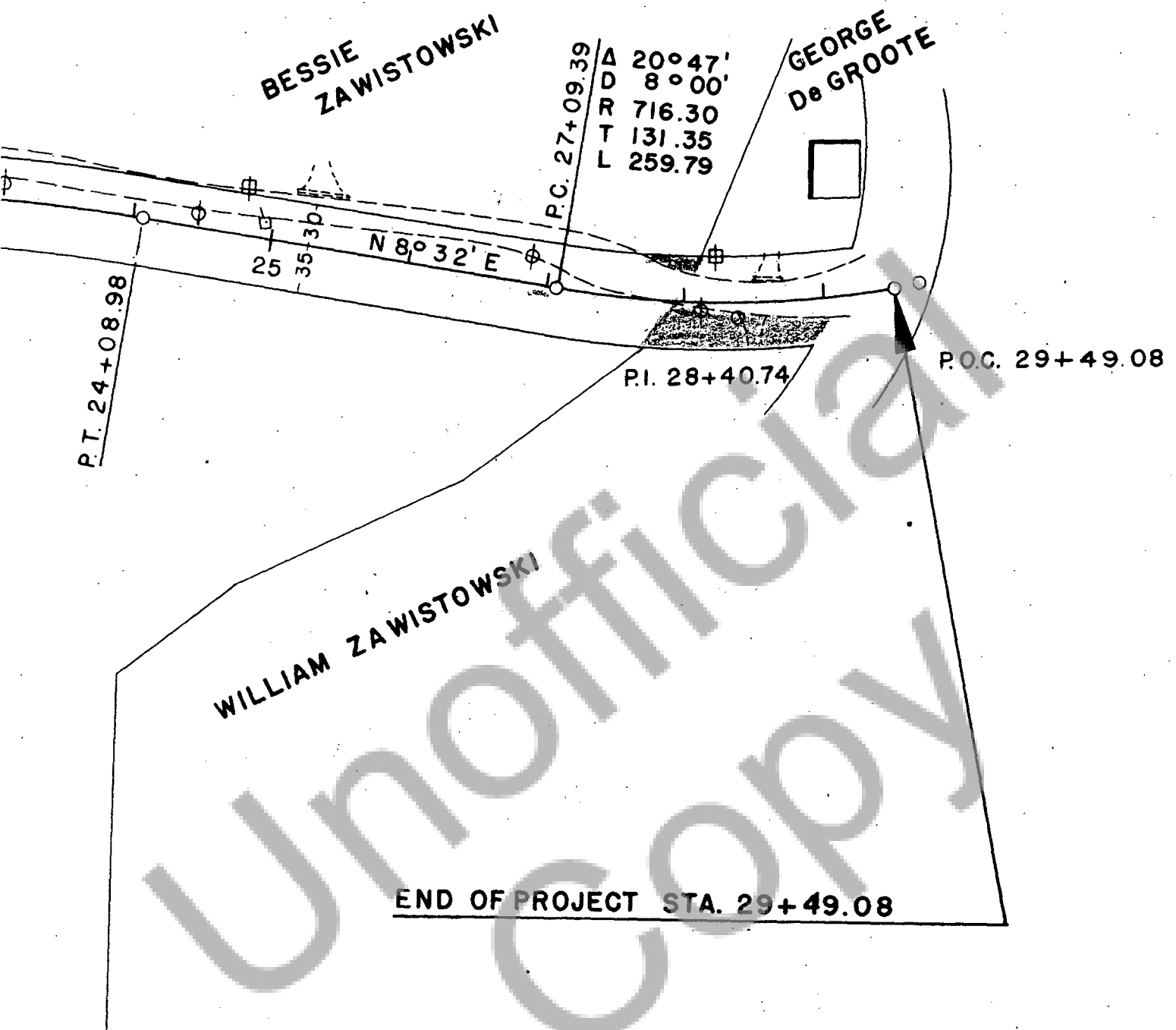
