COMMUNITY PROPERTY AGREEMENT.

THIS AGREEMENT, Made and entered into this 6th day of October, 1950, by and between Garfield R. Klinger and Bessie J. Klinger, husband and wife, residing at Stevenson, Skamania County, State of Washington, witnesseth:

That, whereas, said Garfield R. Klinger and Bessie J. Klinger are the owners of certain real and personal property situate in Skamania County and elsewhere in the State of Washington, the same being now held in the name of said Garfield R. Klinger and Bessie J. Klinger, and being desirous that said property and any other real estate and personal property that may be hereafter acquired in the name of said Garfield R. Klinger and Bessie J. Klinger, or in the name of either of them by gift, purchase or inheritance, shall pass without delay or expense in case of the death of either of said parties to the survivor.

NOW, THEREFORE, in consideration of the love and affection that each of said parties has for the other, it is hereby agreed that in case of the death of the said Garfield R. Klinger while the said Bessie J. Klinger survives, the whole of said property hereinbefore referred to, together with any and all other real and personal property by them or either of them hereafter acquired in the name of said Garfield R.
