the following described Real Estate A right of way for the relocation of the County Road known and designated Skamania Landing Road (County Road No. 16) Section, P.S.H. 830 South in the S.W. $\frac{1}{4}$ of the N.W. $\frac{1}{4}$ of Section 35, Township 2 North, Range 6 E.W.M. in Skamania County, Washington, more particularly:

A strip of land lying northerly of and contiguous to the existing County Road and southerly of a line drawn parallel to and 30 feet distance when measured radially and/or perpendicularly from the following described centerline from approximate Station 0 + 79 to Station 4 + 00; thence to a point 40 feet distant northerly when measured perpendicularly to centerline at Station 5 + 00; thence to a point 30 feet distant northerly when measured perpendicularly from centerline at Station 5 + 38.71; thence parallel to and 30 feet distant northerly when measured radially from centerline Stations 5 + 38.71 to Station 6 + 44.68.

Centerline Description

Beginning at Station 0 + 00 which lies at the intersection of said Skamania Landing Road with centerline of P.S.H. 830, South 1,855.06 feet and East 42.89 feet from the northwest corner of Section 35, Township 2 North, Range 6 E.W.M.; thence S 16° 19' E 84.96 feet; thence S 50° 53' E 51.98 feet to Station 1 + 41.29 being the P.C. of a 16° 00' curve to the left; thence following said curve 103.23 feet to Station 2 + 44.52; thence S 67° 34' E 294.19 feet to Station 5 + 38.71 being the P.C. of a 50° 00' curve to the right; thence following said curve 105.97 feet to P.T. Station 6 + 44.68.

Excepting existing Right of Way

Contains 0.31 acres more or less.
