 thence S 64° 34' E 25.00 feet to point of beginning.

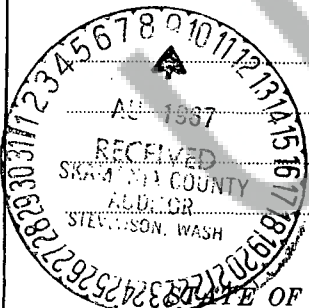
