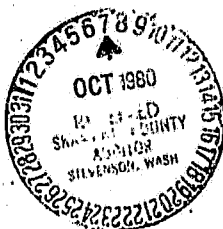

Partial Release of Mortgage

KNOW ALL MEN BY THESE PRESENTS, That RIVERVIEW SAVINGS ASSOCIATION, a Washington corporation, the owner and holder of that certain mortgage bearing date the 28th day of September, 1977, executed by CORINNE V. Yule Short Plat, recorded June 26, 1979 in Book 2 of Short Plats, at page 111, records of Skamania County, Washington;

Together with and subject to an easement for ingress, egress and utilities being 20 feet in width, over, under and across the West 905 feet of the North 440 feet of the North half of the said Northeast quarter and connecting with Skye Road; Reserving to the Grantor, heirs and assigns an easement for ingress, egress and utilities over, under and across the North Ten (10) feet of Lot 4 of Corinne V. Yule Short Plat as described above.
