RESERVING TO THE GRATOR, HEIRS AND ASSIGNS AN EASEMENT FOR INGRESS, EGRESS AND
UTILITIES OVER, UNDER AND ACROSS THE NORTH TEN (10) FEET OF LOT 4 OF CORRINE V.
