That portion of the southeast quarter of Section 25, Township 2 North, Range 2 E10W, as follows: Beginning at a point 40 chains north and 20 chains west of the southeast corner of the said Section 25; thence west 5 chains; thence south 20 chains; thence east 4 chains; thence north 5 chains; thence east 2 chains; thence north 4 chains; thence west 2 chains; thence north 11 chains to the point of the beginning. EXCEPT that portion thereof lying southerly of the center line of the County road known and designated as the Baker Road. AND EXCEPT that portion thereof described as follows: Beginning at a point 40 chains north and 20 chains west of the southeast corner of said section 25; thence west 5 chains; thence south 465 feet to the initial point of the tract hereby described; thence east 200 feet; thence south 115 feet; thence west 200 feet; thence north 200 feet to the initial point.

And the mortgagee promises and agrees to pay before delinquency all taxes, special assessments and other public charges levied, assessed or charged against said described premises, and to keep all improvements on said described premises insured against loss or damage by fire by the sum of 500 less than Two Thousand Six Hundred Sixty-five and 22/100 Dollars (\$2,665.22), for the benefit of the mortgagee and to deliver all policies and receipts on the mortgagee.
