

## 1 DECLARATION OF HOMESTEAD

6 KNOW ALL MEN BY THESE PRESENTS, That CLYDE F. COOKE  
7 and EVELYN V. COOKE, are husband and wife, and that they reside  
8 at North Bonneville, Washington, in Skamania County, and that they  
9 are the identical persons making this Declaration of Homestead  
10 and are the heads of a family consisting of themselves and their  
11 children.

12 That we reside at North Bonneville, Washington and that  
13 we own in our own right the following described tract of land  
14 located in Skamania County, State of Washington, to-wit:

30 contract dated January 31, 1959, in fulfill-  
31 ment of which this conveyance is made.

32 That said real estate and premises owned by these  
parties is used exclusively for a home and dwelling house by the  
parties and which property will not be devoted exclusively to any  
other purpose and that the value thereof together with the improve-  
ments thereon does not exceed \$6,000.00 exclusive of any mortgages,  
mechanic's or materialmen's liens.
