

633—WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That Theodore Blohm

hereinafter called the grantor, Ten Dollars, in consideration of and other good and valuable consideration to grantor paid by

Vernon A. Good, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of SKAMANIA and State of Washington described as follows, to-wit: A tract of land located in Sec. 15, Township 3 North, Range 9E, being portions of Manzanola Orchard Tracts, according to the official plat thereof on file and of record in the Auditor's office of Skamania County, Washington, and more particularly described as follows:

S 1/2 Lots 1 and 2, all of Lots 3 and 4 of Block 14; S 1/2 Lot 2, and all Lot 3 of Block 15; S 1/2 Lot 1, all Lot 2, and NW 1/2 of N 1/2 of Lot 3 of Block 17.

Also a tract of land located in Lots 1 and 2 of Block Sixteen, beginning at a point on the west line of said Lot 2 north 200 feet from the southwest corner thereof; thence south 200 feet to the southwest corner of Lot 2; thence along the south line of Lot 2 east 255 feet, more or less, to a point 405 feet west of the southeast corner of Lot 2; thence north 100 feet; thence in a northeasterly direction to a point 312 feet north of the southeast corner of Lot 2; thence east 245 feet, more or less, to the westerly line of the Jessup Road; thence north 30 feet; thence west 245 feet, more or less, to a point on the east line of Lot 2; thence in a southwesterly direction parallel to, and 30 feet distant from, the fourth course above described to a point due east of the point of beginning; thence west to the point of beginning.

To Have and to Hold the above described and granted premises unto the said grantee and grantee's heirs, successors and assigns forever.

And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances with no exceptions.

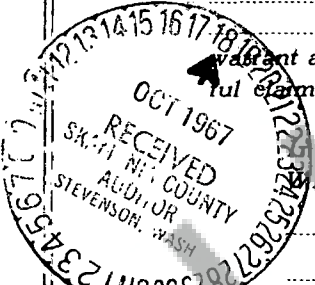

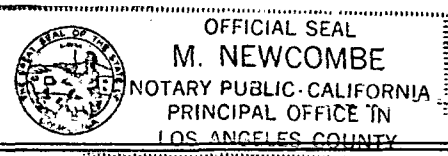

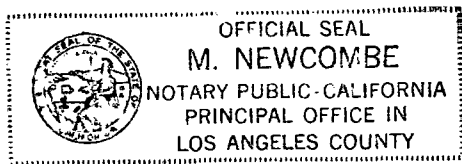
