

COMMUNITY PROPERTY AGREEMENT

THIS COMMUNITY PROPERTY AGREEMENT entered into this day by and between E. P. ASH and GERTRUDE E. ASH, husband and wife, of Stevenson in Skamania County, State of Washington:

WITNESSETH:

WHEREAS, the parties hereto are the owners of certain real property situated in the State of Washington; and

WHEREAS, it is contemplated by the parties hereto that in the future they may acquire additional real property situated in the State of Washington; and

WHEREAS, it is the desire hereto that all of their real property situated in the State of Washington shall pass to the survivor without delay or expense in the event of the death of either party;

NOW THEREFORE, we, E. P. Ash and Gertrude E. Ash, husband and wife, for and in consideration of the love and affection which we have one for the other, do hereby mutually agree that all of the real property which we now own separately, jointly or otherwise, and situated in the State of Washington, shall be and it is hereby declared to be the community real property of the parties, and each of the parties to this agreement does hereby convey and transfer to the community all real property owned by them in the State of Washington, even though the same be held in his or her separate estate; and

We hereby mutually agree that all of the real property which shall hereafter be acquired by either of us, whether separately, jointly or otherwise, and of whatsoever nature and situated in the State of Washington, shall be and it is hereby declared to be community real property, and each of the parties does hereby convey and transfer to the other and to the community all such real property hereafter acquired by either of them, even though the same be acquired in his or her separate estate; and

IT IS FURTHER AGREED that the whole of the community real property now owned by us or hereafter acquired by us in the State of Washington, including all real property the status of which is changed or created by this agreement, shall at once, in the event of the death of E. P. Ash while the said Gertrude E. Ash survives, be vested in

Gertrude E. Ash absolutely and in fee simple as her sole and separate real property; and in the event of the death of the said Gertrude E. Ash while the said E. P. Ash survives, then the whole of the community real property now owned by us or hereafter acquired by us in the State of Washington, including all real property the status of which is changed or created by this agreement, shall at once vest in the said E. P. Ash absolutely and in fee simple as his sole and separate real property.

IT IS FURTHER AGREED that this community property agreement shall pertain only to real property situated in the State of Washington.
